

PURPOSE OF CHARTER

The Board of Education ("Board") for the District desires to make continual improvements to existing programs. As a result, the Bond Program Oversight Committee Charter ("Charter") is adopted to explain the mission, purpose, structure, membership, duties, responsibilities, and expectations. This Charter supersedes the previously adopted charter dated August 30, 2010.

COMMITTEE MISSION

The HISD Board, in response to community interest in the effective and efficient use of bond proceeds, has established a mechanism to encourage greater accountability, transparency, public support, and confidence by creating the Committee. The Committee is an independent citizens' Committee that is responsible to the Superintendent, Board, and general public (in that order).

The Committee's charge is to monitor all applicable Bond funded construction projects and help interested Houstonians to stay informed about new construction and renovation projects in the District. Its purpose is to monitor performance and compliance in order to confirm that HISD implements Bond Program work in conformance with the program approved by the Board and make recommendations to maximize available resources to achieve construction goals in the most effective and cost efficient manner. Its focus should be oversight rather than limited to hindsight.

COMMITTEE STRUCTURE AND MEMBERSHIP

- a) The Committee has up to nine voting members, including a Chairperson and Vice Chairperson, who are appointed by the Superintendent. Formal action from the Committee requires a majority vote of the quorum present. Individual members of the Committee shall not exercise authority for the Committee as a whole and shall not act independently of the Committee. Written applications will be reviewed by members of the District's Executive Leadership team for each applicant's experiences and qualifications. The Executive Leadership team will submit recommendations to the Superintendent for approval and appointment to the Committee.
- b) Appointments will be staggered for one year and two year terms. Terms may be extended for additional one or two year terms upon approval by the Superintendent.
- c) The Committee will approve meeting minutes, review and approve the reasonableness of reports from the District, and approve the issuance of status reports and other communications from the Committee.
- d) All meetings will be open to the general public.
- e) Membership on the Committee shall consist of interested persons from the following groups who can remain objective and independent with the District's best interest at heart:
 1. Special preference for members with expertise or knowledge in the areas of building design/ engineering, construction, construction project management, and/or finance.
 2. Members active in a business organization representing the business community located in the District.
 3. Members who are parents or guardians of a child enrolled in the District and also active in a parent-teacher organization.
 4. Members of the community at-large.


- f) The Committee members receive no direct or indirect compensation from the District for their services as members of the Committee.
- g) The Committee members may not have an active contract or be seeking a contract with the District or with any contractor or sub-contractors associated with the Bond Programs.
- h) The Committee may not include any employee or official of the District, or any vendor, contractor or consultant of the District.
- i) A Committee member serves the general interest of the public as opposed to any personal interest or special interest group.
- j) If a Committee member moves outside of the District's geographic boundaries, resigns, violates the Ethics Policy contained herein, fails to attend two consecutive Committee meetings without reasonable excuse, or otherwise becomes unable to serve on the Committee, the Superintendent may declare the position on the Committee to be vacant and appoint another qualified person to the Committee.

COMMITTEE DUTIES AND RESPONSIBILITIES

The Committee shall inform the Superintendent, Board, and general public (in that order) concerning the District's overall project management of all Bond Programs, including but not limited to:

- a) Review periodic reports produced by the District to verify effective and efficient use of bond proceeds and compliance with the purposes set forth in the Bond Programs as approved by the Board. See reports issued by the District in the "District Duties and Responsibilities" section below.
- b) Ensure that bond revenues are expended for the purpose set forth in the Bond Programs as approved by the Board of Education, and that any deferred proposals or plans where considered necessary are appropriate.

- c) Validate that no bond funds are used for any teacher or administrative salaries or other school operating expense, other than administrative salaries whose primary purpose is to manage the District's Bond Programs.
- d) Review efforts by the District to maximize bond revenues by balancing best value, quality, and efficiency in meeting the District's goals and priorities.
- e) Evaluate risks and related controls associated with the District's Bond Programs, determine focus areas and strategic approach to review, and communicate any findings and recommendations for improvement via a periodic independent report to the Superintendent, Board, and general public. To maximize these efforts, the Committee may recommend the performance of specific audit projects based on its risk assessments and communications to the Board Audit Committee and HISD Office of Inspector General.
- f) Coordinate with the Superintendent's designee to visit District facilities and grounds for which bond proceeds have been or will be expended, in accordance with any necessary access procedures.
- g) Review copies of other bond reports published by the District.
- h) Review any performance audits of the District's Bond Programs to ensure the District is taking appropriate action to remediate any deficiencies identified in such reports.
- i) Review operational audits conducted by the HISD Office of Inspector General to ensure the adequacy of scope, management action plans, and remediation efforts of the District.
- j) Review any financial audits of the District's Bond Programs to ensure the District is taking appropriate action to remediate any deficiencies identified in such reports.
- k) Provide periodic status reports and an annual report regarding the results of its activities, in addition to any Committee findings, recommendations, and management action plans, to the Superintendent and





Board. These reports should include the Committee's opinion regarding the District's remediation efforts for any recommendations included in the performance audits, operational audits, or financial audits mentioned above and will be made available to the general public by inclusion on the District's website and other communication avenues.

- l) Perform other reasonable duties requested by the Superintendent.
- m) Disclose and sign an annual conflict of interest statement for existing conflicts and re-submit if any conflicts arise during a Committee member's tenure.
- n) Any perceived allegation of wrongdoing; potential waste, fraud, misuse or abuse; or non-compliance with Local, State, Federal laws/regulations, or District policies that becomes known to the Committee shall be communicated to the Superintendent, who shall refer such matters to the Board, Ethics and Compliance Officer, Office of Inspector General, and outside legal counsel where appropriate.

The Committee provides counsel and input to the administration and the Board, but it does not have management or policy-setting responsibilities. Also, the Committee does not have a fiduciary responsibility to the District or Board, nor are its members personally liable to the District or Board. The Committee is not responsible for:

- a) Approval of construction contracts or change orders;
- b) Appropriation of construction funds;
- c) Handling of legal matters;
- d) Approval of construction plans and schedules;
- e) Approval of the District's maintenance plan;
- f) Approval of the sale of bonds;
- g) Establishment of priorities and order of construction for the bond projects;
- h) Selection of architects, engineers, construction managers, project managers, and such other professional service firms;
- i) Approval of the design for each project including

exterior materials, paint color, interior finishes, site plan and construction means or methods;

- j) Selection of independent audit firm(s), performance audit consultants and such other consultants as are necessary to support the performance of the Bond Programs;
- k) Setting or approving schedules of design and construction activities;
- l) Investigations of alleged wrongdoing; potential waste, fraud, misuse or abuse; or non-compliance with Local, State, Federal laws/regulations, or District policies.
- m) Directing the activities of staff or consultants; or
- n) Activities, roles or responsibilities that have been delegated to staff or consultants by the Superintendent or his designee.

COMMITTEE MEETINGS


- a) The Committee shall meet at least quarterly to review the District's Bond Program's status and related information, and to perform other duties as provided herein. The Superintendent, Chairperson, or Vice Chairperson may convene additional meetings, if necessary.
- b) All Committee meetings shall be held within the District's geographic boundaries.
- c) Minutes will be prepared by a representative of the District and will be distributed to the Committee within 15 business days. The minutes will be voted upon for the record at the next scheduled Committee meeting.

DISTRICT DUTIES AND RESPONSIBILITIES

- a) The Chief Operating Officer shall act as the Superintendent's designee to the Committee.
- b) The Superintendent or his designee shall oversee management's action plan to respond to any

written report from the Committee with findings or suggestions for improvement within 15 business days. All recommendations and management action plans from inception to date will be tracked and made available to the Committee and Board. The District's website and other communication avenues will also publicize the Committee's report and management's action plan for use by the general public.

- c) The District shall have a commitment to the Committee, provide open communication, and provide necessary technical and administrative assistance in a timely fashion as follows:
 - 1. Provision of a meeting room, including any necessary audio/visual equipment;
 - 2. Preparation and copies of any documentary meeting materials, such as agendas and reports; and distribution of those materials to the Committee in a timely manner;
 - 3. Provision of a quarterly summary progress report covering the Bond Programs;
 - 4. Access to other information to effectively perform its oversight function.
 - 5. Retention of all Committee meeting records, and providing public access to such records on the District's website; and
 - 6. Notify the public of Committee meeting times and locations. The meetings are open to the public.
- d) Summary progress reports will communicate and provide an explanation for the following attributes in a clear concise manner. As part of reporting, HISD will identify projects that experience a significant impact to schedule, budget, or scope of work. Detail reports can be provided upon the Committee's request.
 - 1. Project schedules with anticipated completion dates and current status.
 - 2. Project scope
 - 3. Contingency report (change allowance, encumbrances, and available budget)
- 4. Expenditure reports
- 5. Status of Minority/or Woman Owned Business Enterprise (M/WBE)
 - e) The appropriate District staff, District consultants, and/or designees shall attend all Committee proceedings in order to provide a status update for their area of responsibility as it relates to the Bond Programs and answer any questions from Committee members.
 - f) The Office of Inspector General will consider the input and specific audit requests of the Committee and HISD management during its development of the Annual Audit Plan. Audit projects conducted by the Office of Inspector General will be completed by the issuance of a formal audit report, which will be provided to the Board Audit Committee and made available to the Committee. Such reports will be publicized on the District's website for use by the general public.
 - g) The District acknowledges that the Committee may request certain information that is sensitive or legally privileged. The District will use the counsel of its legal advisor to comply with such requests within the limits of Texas law and the best interest of the District.





ETHICS POLICY

This Ethics Policy provides general guidelines for Committee members to follow in carrying out their roles. Not all ethical issues that Committee members face are covered in this Policy. However, this Policy captures some of the critical areas that help define ethical and professional conduct for Committee members. The provisions of this Policy were developed from existing laws, rules, policies and procedures as well as from concepts that define generally accepted good business practices. Committee members are expected to strictly adhere to the provisions of this Ethics Policy.

POLICY

CONFLICT OF INTEREST. A Committee member shall not make or influence a District decision related to: (1) any contract funded by bond proceeds or (2) any construction project that will benefit the Committee member's outside employment, business, or provide a financial benefit to the Committee member or a family member, such as a spouse, child, parent, or sibling.

OUTSIDE EMPLOYMENT. A Committee member shall not use his or her authority over a particular matter to negotiate future employment with any person or organization that relates to: (1) any contract funded by bond proceeds; or (2) any construction project. A Committee member shall not make or influence a District decision related to any construction project involving the interest of a person with whom the member has an agreement concerning current or future employment, or remuneration of any kind. For a period of one (1) year after leaving the Committee, a former Committee member may not represent any person or organization for compensation in connection with any matter pending before the District that, as a Committee member, he or she participated in personally and substantially.

COMMITMENT TO UPHOLD LAW. A Committee member shall uphold the federal and Texas Constitutions, the laws and regulations of the United States and the State of Texas, and the policies, procedures, rules and regulations of the Houston Independent School District.

COMMITMENT TO DISTRICT. A Committee member shall place the interests of the District above any personal or business interest of the member.

MEMBER CERTIFICATION. A Committee member shall certify his or her understanding of Committee's Ethics Policy and disclose and sign an annual conflict of interest statement for existing conflicts and re-submit if any conflicts arise during their tenure.

EXECUTIVE SUMMARY

The Houston Independent School District began 2019 with the opening of six new schools, making for an active first quarter as the 2012 Bond Program nears completion.

Schools welcoming students to new facilities upon their return from winter break on Jan. 7 include Kinder High School for the Performing and Visual Arts, Barbara Jordan Career Center, Wharton Dual Language Academy, Sam Houston Math, Science and Technology Center, and Madison and Worthing high schools. Additional site work, including abatement and demolition of old buildings, is ongoing at Madison, Sam Houston, and Jordan.

Only four bond schools remain under active construction for their original scope of work — Lamar, Bellaire, Northside, and Austin high schools. Of those, two — Northside and Lamar — will be completed and opened by the start of the 2019-2020 school year.

Aside from these projects, realignment projects continue across the district, with major construction at seven campuses — Westbury, Waltrip, Wisdom, Washington, Yates, and Milby high schools and Pilgrim Academy. These are new, board-approved projects that were not part of the original scope of work but are funded by surplus bond funds.

Work continues to rebuild four elementary schools — Scarborough, Braeburn, Kolter, and Mitchell — that sustained significant damage due to Hurricane Harvey. Currently, demolition and abatement has been completed at all four campuses. These projects are not funded by the bond program but are overseen by Bond Program and Construction Services staff.

The team also led the planning, promotion, and execution of three building dedication ceremonies, two grand opening celebrations, and the final groundbreaking ceremony of the 2012 Bond Program. Milestone event scheduling and planning is ongoing for 10 more schools.

DESIGN MILESTONES

The Facilities Design team made significant progress on several ongoing projects. Design work concluded on several large realignment projects, including the Westbury High School Fine Arts wing and new indoor practice pool facilities at Milby, Washington, and Yates high schools.

Additionally, several schools were highlighted for their outstanding design. Energy Institute High School was featured in the Spring 2019 edition of Learning by Design magazine, a premier source for education design innovation and excellence. The Kinder High School for Performing and Visual Arts was named a Houston Business Journal 2019 Landmark award winner. This annual award program recognizes impressive real estate projects that make a significant impression on the Houston landscape and help sculpt the look, feel, and image of the city.

Three recently constructed schools also received Leadership in Energy and Environmental Design (LEED) certifications from the U.S. Green Building Council — Debakey High School for Health Professionals, High School for Law and Justice, and North Forest High School. This brings HISD's total number of LEED certified buildings to 29. Not only will these facilities serve as environmentally-friendly neighbors in their communities, but studies have shown that students and teachers who teach and learn in these buildings are more engaged and have increased achievement and fewer absences.

The Logistics and Furniture, Fixtures, and Equipment teams continue to work together on furniture selection, delivery, and installation. Installations and moves were completed at Wharton Dual Language Academy, Barbara Jordan Career Center, Sam Houston Math, Science and Technology Center, and Madison and Worthing high schools. Additional installations and moves are underway at Lamar High School and at the Westbury High School fine arts addition. To date, the Fixtures, Furniture and Equipment team has ordered more than 70,000 pieces of furniture, fixtures, and equipment.

M/WBE NETWORKING ACTIVITIES

The Office of Business Assistance held and participated in multiple programs to promote HISD business, bid opportunities and pre-bid meetings to their extensive contact list of minority companies during the first quarter. The Supplier Diversity team sponsored three Workshop Wednesday meetings, which are held monthly to provide information to M/WBEs on topics of interest. First quarter workshop topics included how to do business with HISD, project management for controlled outcomes, and crisis communication planning.

The Business Assistance/Supplier Diversity team also participated in thirteen outreach events and continued its partnership with the Interagency Mentor-Protégé Program. The current M/WBE participation rate for 2012 Bond projects is 28.17 percent — above the 20 percent goal originally set by program officials.

STRATEGIC ENGAGEMENT AND OUTREACH

The Strategic Engagement and Outreach team spent the first quarter providing communications support to ensure parents, community members, and all HISD stakeholders stayed abreast of the 2012 Bond progress.


The team started the first quarter providing opening-day coverage to highlight the first day of students at six new campuses, all of which opened their doors in January. Coverage included news stories, social media posts, and photos.

During the first quarter, there were six milestone celebrations, including building dedication ceremonies for Askew Elementary School, Parker Elementary School, and Wilson Montessori, grand opening celebrations for Worthing High School and Kinder High School for the Performing and Visual Arts, as well as the final groundbreaking ceremony of the 2012 Bond Program held at Bellaire High School.

The team continued to focus on promoting the significant progress made under the 2012 Bond through updating the bond website, writing and distributing project updates, coordinating media coverage, developing abstracts for 2012 Bond presentations at national conferences, publishing the monthly Building Excellence newsletter, and promoting the @Build_HISD twitter account.

REAL ESTATE

With all purchases complete under the 2012 Bond Program, the Real Estate department is maintaining and renewing current lease agreements as needed, assisting project managers with land planning issues, and searching for possible sites for future development. The department continues to supplement and maintain the centralized database of key documents for all HISD properties.



1. Funding within this bond for North and South Early College will be combined with funds previously allocated from the 2007 bond for these projects to meet the schools programmatic needs.
2. HSPVA moved to district 8 due to a proposed site for the new school located at 1300 Capital.
3. Program costs allocated to each project budget will be separated into various program budgets to provide better oversight and financial management, at a later date.
4. New schools / replacement projects will undergo a school site specific ed-spec development process and all schools will undergo a scope to budget process.
5. Project budgets include allocations for planning, design, construction, administration, and other related costs.
6. The current allocation for the Young Men's College Preparatory Academy (YMCPA) will allow for a demolition of the EO Smith facility, the addition of a smaller facility, and the renovation of the HP Carter facility for use by the YMCPA. An alternate plan for the project to include the demolition of both the EO Smith and HP Carter facilities and the building of a new school would cost an additional \$13,727,000.
7. Condit ES will be rebuilt and funded from surplus bond funds and/or the sale of real estate.
8. High School for Law Enforcement and Criminal Justice will be rebuilt and funded from surplus bond funds and/or the sale of real estate.

2012 Project Update Report

Technology upgrades at all schools: \$100 M

The 2012 Bond allocated funding for network improvements and wireless expansion.

Project Status

The 2012 Bond Program allocated \$100 million in funding for technology upgrades, network improvements, and wireless expansion at schools across the district. The scope of the work includes the addition of wireless access points, cabling, and other infrastructure equipment, such as network switches and Voice over Internet Protocol (VoIP). These improvements allow for the expansion of digital instruction, as well as safety and security improvements like telephones in classrooms. As the installation of technology upgrades continue throughout the district, the VoIP project has completed installation of handsets in every classroom and additional phases are still ongoing.






2012 BOND CONSTRUCTION M/WBE BREAKDOWN BY PROJECT TYPE




2012 BOND CONSTRUCTION M/WBE BREAKDOWN BY PROJECT TYPE



The total budget for the 2012 Bond Program is \$1.89 billion. Additionally, the Board approved \$212.4 million in October 2015 for a total of \$2.102 billion. Of that amount, \$1,840,390,023 is committed including encumbrances of \$179,484,447 and actual expenditures of \$1,660,905,576. A total of \$262,059,940 is available to complete projects.


TOTAL BUDGET, COMMITMENTS & AVAILABLE FUNDING TO DATE



EXECUTIVE SUMMARY

With six campuses opening in January, the Strategic Engagement and Outreach team mobilized to highlight students' first day at their new campuses.

On Jan. 7, the team was dispatched throughout the district to provide extensive, on-site communications coverage for each of the six schools that opened for the first day of the spring semester — Kinder High School for the Performing and Visual Arts, Barbara Jordan Career Center, Wharton Dual Language Academy, Sam Houston Math, Science and Technology Center, and Madison and Worthing high schools.

Team members wrote stories that appeared on the district and bond program websites, took photos, and posted updates on social media.

The team also led the planning, promotion, and execution of the building dedication ceremonies for Askew and Parker elementary schools, and Wilson Montessori, the grand opening celebrations for Worthing High School, and Kinder High School for the Performing and Visual Arts. The team also coordinated the groundbreaking ceremony at Bellaire High School — the final groundbreaking ceremony of the 2012 Bond Program. Milestone event scheduling and planning is ongoing for Wharton Dual Language Academy, Barbara Jordan Career Center, Sam Houston Math, Science and Technology Center, and Madison High School.

Team members continue to attend Project Advisory Team meetings and internal strategy meetings, as needed, to assess communications needs and provide guidance to district leadership and project managers on strategies to engage more effectively with stakeholders.

The team also continued to cultivate the following of the @Build_HISD Twitter account, posting more than 160 tweets, earning more than 303,500 impressions and 842 profile visits, and gaining 53 new followers during the first quarter, bringing the total followership up to 829.

GLOSSARY OF TERMS

BAS

Building Automation System (HVAC and lighting controls)

Change order

A modification to the original construction contract authorizing a change in the work or an adjustment in the amount of the contract or the contract time. The original contract price may not be increased by more than 25 percent by change order.

Competitive Bidding

A procurement method by which a governmental entity contracts with a contractor for the construction, alteration, rehabilitation, or repair of a facility by awarding the contract to the lowest responsible bidder.

Competitive Sealed Proposal (CSP)

A procurement method by which a governmental entity may request proposals and pricing information based on the scope of work provided, rank the offers, negotiate a contract, and then award the project to the contractor that offers the best value to the entity.

Construction commissioning

A collaborative process whose purpose is to ensure that buildings and systems perform according to contract.

Commissioning agent

An independent party, unaffiliated with the design team or contractors, that takes charge of the construction commissioning process.

Construction documents

Extremely detailed drawings and specifications showing and describing all of the details required to construct the building.

Construction Manager at Risk (CMAR)

A construction delivery method by which a governmental entity contracts with an architect or engineer for design and construction phase services and contracts separately with a construction manager-at-risk to serve as the general contractor and to provide consultation during the design and construction, rehabilitation, alteration, or repair of a facility. A CMAR is selected based upon qualifications and price proposal that would provide the best value for the governmental entity.

Daylighting

A planned energy conservation strategy that utilizes illumination from sunlight.

Design development

Process in which schematic design drawings are further developed to include more detail, including: detailed site plan; room layouts; door and window types; interior and exterior elevations; reflected ceiling plans; plumbing, mechanical, structural, and electrical drawings; and kitchen layouts.

Design team

A group of professionals from architectural and engineering firms that is engaged to design a facility.

Educational Specifications

A document that details the number of rooms required, the size of each room, how those rooms should relate to each other (adjacencies), and the elements (sinks, electrical outlets, markerboards, cabinets, etc.) that should be included in each room. Districtwide Educational Specifications will be adapted for the specific needs of the campus.

Encumbrance Accounting

The recognition of commitments that will subsequently become expenditures when goods and services are received.

FF&E

Furniture, fixtures, and equipment. This describes all contents that are not a permanent part of the structure.

Hard costs

Expenses associated with direct construction of a project.

HVAC

Heating, ventilation, and air-conditioning

Job Order Contract (JOC)

A procurement method used for maintenance, repair, alteration, renovation, remediation, or minor construction of a facility when the work is of a recurring nature, but the delivery times, type, and quantities of work required are indefinite.

Leadership in Energy and Environmental Design (LEED)

A building certification process developed by the U.S. Green Building Council (USGBC) to enhance environmental awareness among architects and building contractors and to encourage the design and construction of energy-efficient, water-conserving buildings that use sustainable or green resources and materials.

MEP

Mechanical/electrical and plumbing systems.

Program or Concept design

Single-line drawings that illustrate room adjacencies and scale

Public Facility Corporation

The PFC is a non-profit corporation, the creation of which was sponsored by the District pursuant to the Public Facility Corporation Act. The Public Facility Corporation act authorizes the creation and utilization of school district public facility corporations to issue bonds for capital renovation programs. The Houston Independent School District Public Facility Corporation (HISD-PFC) has utilized this structure to issue \$48M for four of the news schools in the 2007 Facilities Capital Program (FCP).

Schedule of values

An itemization of costs that comprises the entire contract amount.

Schematic Design

The schematic design submission typically includes a simple site plan, floor plans (simple scale drawings that show room sizes, relationships, doors, and windows), simple building cross sections, an outline specification with general information about building systems, a table comparing required square footages from the educational specifications with actual square footages shown on the drawings, a preliminary estimate of cost options, and possibly 3-dimensional depictions of the exterior of the building.

Scope-to-Budget


An analytical review conducted by the architectural/engineering team to ensure the proposed scope of work and project requirements are aligned with the established construction budget. The approved findings from this review become the basis for the design and preparation of the construction documents.

Soft costs

A construction industry term, but more specifically a contractor accounting term for an expense item that is not considered direct construction cost. Soft costs include architectural, engineering, financing, legal fees, and other pre- and post-construction expenses.

Swing space

A school building or a portion of an existing school building or other facility that will house the student population and its teachers and staff during the school-construction process.

Bond Oversight Committee Meeting Status Report February 12, 2019

Bond Oversight Committee Tours Kinder HSPVA, hears bond program update.

HISD's Bond Oversight Committee toured the newly opened Kinder High School for the Performing and Visual Arts on Tuesday at their quarterly meeting to review progress of the 2012 Bond Program.

HSPVA Principal Scott Allen and HISD General Manager of Facilities Design Dan Bankhead led the eight-member committee as they walked through the school's grand entry hall, the 800-seat Denny Theater, the black box theater and the recital hall.

The tour also included a student exhibit in the visual arts wing and visits to the ceramic and sculpture studios, a recording studio, a creative writing lab, two-story high dance studios, the band and orchestra hall, and the choral music room.

After the tour, the committee was briefed on fourth quarter 2018 progress by General Manger of Construction Services Andreas Peeples.

Those schools, which opened in January, include Kinder HSPVA, Barbara Jordan Career Center, Wharton Dual Language Academy, Sam Houston Math Science and Technology Center, and Worthing and Madison high schools.

Peeples noted that with the latest round of openings, school construction is now 85 percent complete, with only four 2012 Bond projects – Lamar, Bellaire, Northside, and Austin high schools – remaining under construction and yet to open.

Looking ahead, Chief Operating Officer Brian Busby reported that the team is currently researching what projects a new bond program would encompass.

Busby said the team is putting together a community engagement strategy and looking toward 2020 for putting forward a new bond referendum.

The general purpose of the meeting was to brief the Bond Oversight Committee on third quarter progress of the new construction and renovation projects funded through the 2012 Facilities Capital Program. Related issues, questions, and activities were also discussed:

- Item 1 Welcome**
Bond Oversight Committee members and other guests met in the first-floor lobby of Kinder HSPVA in preparation for a tour of the school. Construction Services General Manager Andreas Peeples and Facilities Design General Manager Dan Bankhead welcomed the group at 8:45 a.m.

- Item 2 Kinder HSPVA Tour**
Kinder HSPVA Principal Scott Allen led the group on an abbreviated tour of the school, including the 800-seat main theater, multiple secondary theaters, music and dance studios, the creative writing department, the fitness center, flexible learning spaces, and traditional classrooms.

- Item 3 Minutes from October 23 Meeting**
Mr. Peeples began the business portion of the meeting at 9:45 a.m. by asking Bond Oversight Committee members to approve the minutes from the October 23, 2018, meeting. They were approved unanimously.

- Item 4 Video Presentation**
Mr. Peeples remarked on the district's impressive feat of opening 21 schools in 2018 and introduced a video presentation highlighting the six schools that were completed in the fourth quarter, in preparation for January 2019 openings. The presentation featured not only footage of the new facilities, but also student interviews detailing how their surroundings impact their learning experience.

- Item 5 Fourth Quarter Construction Update**
Mr. Peeples reported that Kinder HSPVA, Worthing High School, Barbara Jordan Career Center, Sam Houston Math, Science, and Technology Center, Madison High School, and Wharton Dual Language Academy started the spring semester of the 2018-2019 school year in new facilities, bringing school construction to 85 percent completion.

- Item 6 Looking Ahead**
Mr. Peeples reported that only four schools in the bond program remain under active construction: Bellaire High School, Northside High School, Lamar High School, and Austin High School. He reported that three of the recently opened schools have ongoing demolition and sitework: Barbara Jordan Career Center, Sam Houston Math, Science, and Technology Center, and Madison High School. Mr. Peeples also noted schools with major realignment projects include Wisdom High School, Milby High School, Waltrip High School, Booker T. Washington High School, Yates High School, Pilgrim Academy, and Westbury High School.

Bond Oversight Committee Member Phoebe Tudor asked for further explanation of the word “realignment.” Mr. Peeples explained these projects were not part of the original scope of work, but are funded by surplus bond funds.

Bond Oversight Committee Member David Quan asked whether BOC members would receive progress updates about these ongoing realignment projects. Mr. Peeples assured him those would be provided. Business Operations Chief Operating Officer Brian Busby asked Strategic Engagement and Outreach Interim Officer Holly Huffman to include supporting documents about the realignment Board item and specific project details in the committee workbook.


Bond Oversight Committee Member D.V. “Sonny” Flores inquired about recent flooding at Northside High School. Mr. Bankhead said this issue is addressed in the city’s capital plan. Improvements have been made to the drainage system in the area, but the city’s goal is to raise and regrade the street. Mr. Bankhead also mentioned the part of the building that typically floods is being demolished to make way for an elevated section, matching the rest of the school. Mr. Busby noted that, in the meantime, a pump was installed underneath the auditorium to avoid water retention.

Mr. Busby also briefly discussed the possibility of a future bond program, which could go before voters as early as May 2020 or November 2020. He stated that the district could potentially focus on the Westheimer and 288 South corridors, where new schools might be needed to accommodate student growth. Mr. Busby further explained that any future bond program would be guided by community input and noted that Ms. Huffman would lead an effort to engage community stakeholders in discussions about the 20-year capital plan and gather feedback about potential projects.

Mr. Quan asked how a potential state takeover would affect future bonds. Mr. Busby said the plan for another bond would be presented to either the existing board or any other future board, as well as continue conducting surveys to gauge public opinion. Mr. Busby remarked that no one is talking about the district’s record-breaking number of school openings that occurred this year. He said we must shift the narrative and rebrand our district, meaning the next bond election campaign will have to be different than what has been previously done. He said we must actively involve the community in deciding the scope of the bond, based on what voters would likely support.

Bond Oversight Committee member Craig R. Johnson Sr. said a new bond is needed to avoid having to tear down schools that have deteriorated beyond repair. He suggested offering virtual tours of the 2012 Bond schools, so the community can see first-hand the benefits of supporting a bond.

Ms. Tudor asked when the previously mentioned potential bond polling took place. Mr. Busby clarified the district used a firm approximately six months ago and conducted its own unofficial polling among both supporters and detractors. He also said they engaged the loudest voices at board meetings to better understand their concerns. Ms. Tudor said she thinks the 2012 Bond has gone extremely well but is worried that the public only hears about what’s going on with the board and how difficult it will be to counteract that narrative. Mr.



Busby agreed that now is not the right time for a bond election and stated Dr. Lathan shares this view.

Bond Oversight Committee Member Robert M. Eury asked whether there is a point when it will become cost-prohibitive to wait for the right time. Mr. Busby acknowledged the negative side of waiting is deferred maintenance on schools. However, the positive side of waiting until 2020 is increased property values, barring another hurricane or tropical storm. This increase will mean a larger bond with no tax increase. Mr. Busby reiterated that 2020, either May or November, is the ideal time.

Item 7 Supplier Diversity (M/WBE) Report and Community Outreach

Business Solutions General Manager Yesenia Taylor told the committee about three M/WBE workshops that were held during the third quarter — “Beyond the Post-It: Communications for Business Today,” “Driving the Narrative: The Importance of Storytelling,” and “Meet HISD’s Purchasing Services.” She highlighted the latter, sharing that Business Logistics Officer Alexis Licata gave a presentation, which was followed by a networking session in which Ms. Licata met one-on-one with potential suppliers and category specialists. She also discussed other outreach activities in which the team participated, including events with the City of Houston, Greater Houston Black Chamber, Greater Houston Business Procurement Forum, HISD Foundation, Houston Minority Supplier Development Council, and Women’s Business Enterprise Alliance. She noted that the M/WBE participation rate — slightly more than 28 percent — continues to exceed board-established goals.

Item 8 Financial Reports

Senior Manager of Accounting James Moore reported the total budget for the 2012 Bond program was \$2.1 billion, with total commitments through the fourth quarter of \$1,800,675,666, including \$187,522,126 in encumbrances and actual expenditures of \$1,613,153,540. Funds available to complete projects is \$301,774,297.

Mr. White asked whether there would be any funds left over once construction is complete, even after the realignment. Ms. Savoie explained that they do foresee funds remaining, but that it is too early to give an exact figure. Mr. Busby stressed that the financial clock was reset with the March 2017 board item. Ms. Savoie said the extra money will go into the safety and security budget. Mr. White said the district should inform the public of the amount saved. Ms. Savoie said the public tends to pull out their wish list when they learn there is unused money.

Mr. Johnson said the district should proactively train and prepare the emergency response in the case of a school shooting. Mr. Busby noted that HISD is the only school district in the country with an accredited police department. He also shared that when the Parkland, Florida shooting occurred, HISD’s Chief of Police Paul Cordova was called in to help the Parkland Police Department get to implement a system similar to HISD. Mr. Busby also pointed out that we have 36 patrol officers and a cybercrime unit.

Mr. Quan asked for further clarification of the safety and security fund. Ms. Savoie said the district has always had a safety and security fund, but the board item stipulates that any leftover funds from the 2012 Bond will be transferred to the safety and security fund. Mr. Quan asked if there are two separate accounts or just one, with two separate sources. Ms.

Savoie confirmed the sourcing is different. Mr. Quan asked if the committee could obtain information about the current balance of the safety and security fund. Mr. Moore said that can be arranged. Mr. Busby said they could share information about how much was allocated for this purpose in previous bonds — \$90.3 million for the 2007 bond and \$17.2 million for the 2012 bond. Mr. Busby also said Mr. Sanders, as the Superintendent’s designee, is able to move funds within line items as needed.

Mr. Quan asked about the districtwide standard of card access to buildings, specifically whether students are issued cards. Mr. Busby said the goal is for the next bond to include universal cards that will provide entry to buildings and serve as transportation cards, lunch cards and student IDs. Mr. Busby said they increased the number of cameras from around 6,000 to over 16,000. He said when CCTV is added, server capability will also need to be addressed.

Mr. Quan asked how visitors can gain entry to schools with the current security system. Mr. Busby explained that visitors push the intercom at the entrance, ringing the front desk. The staff member inside asks, “How can I help you?” and visitors state their business. Then, the staff member buzzes visitors in. Mr. Busby stated most new campuses have a vestibule, or holding area, where visitors are forced to go to the front desk area and sign in.


Item 9 Strategic Engagement and Outreach

Ms. Huffman reported that the team focused on preparing for the six new schools that opened in January, including working with school administrators to provide transition communications, such as letters, callouts, maps. She said the team also created social media teaser videos in advance of opening day and provided full, on-site opening day coverage to promote the new campuses. Ms. Huffman explained that the team had held four grand openings and one groundbreaking ceremony in the fourth quarter, noting that the team has already held three more milestone events – grand openings for Worthing High School and Kinder HSPVA and a building dedication for Askew Elementary School — during the first quarter of 2019. Ms. Huffman said the team is currently planning about 12 more milestone events, including potential groundbreakings for the four Harvey schools and a groundbreaking for Bellaire, the last 2012 bond school to have such an event. Ms. Huffman also highlighted the team’s shift to a new style of videos which physically showcase the new buildings while letting the narrative detail the academic impact. Ms. Huffman also stated the team worked to shift the style of the quarterly Bond Oversight Committee report from traditional binder to spiralbound report, making it less cumbersome and more cost-effective. She stated her ultimate goal is a digital version.

Item 10 Executive Session

Mr. Sanders thanked attendees participating in the meeting. BOC members then adjourned into Executive Session.
