Minutes: Meeting was brought to order by Dr. Zapata at 3:40 PM

1. Welcome—Dr. Zapata welcomed members to the meeting
2. Snapshot & Data—Dr. Zapata reviewed Snapshot and Data from PowerPoint slides (see attached).
 - a. She highlighted STAAR data comparing 2022 and 2023 information and explained domains and accountability score of 77 (score did not take state data into account as it has not been released). She noted we have work to do and need to focus on improving meets and masters numbers.
 - b. The group discussed that motivating students to do their best on STAAR is a challenge and effort can be invested in leveraging relationships and brainstorming incentives.
 - c. School's CCMR goal is 80%, with efforts aimed at TSI and industry certifications, such as OSHA.
3. The Instructional non-negotiables have been standard practice at our campus and will be maintained moving forward.
4. Updates for 24-25 include:
 - a. 2 new required programs of study to be offered at Westside; Information Technology/Network Systems, and Business, Marketing & Finance Entrepreneurship.
 - b. We will also be offering an AI course.
 - c. 90 minutes of instruction per day will be required for Algebra, English 1 and English 2.
5. Ms. Tran discussed a few budget-related items:
 - a. Enrollment projection for next year will be determined by the finance department based on trends. (previously decided by the campus)
 - b. District announced April 15 deadline for all purchases, presents challenge with 1.5 months remaining in the school year.

2023-24 & 2024 & 25 Instructional Non-negotiables

Schools will comply with District directives and “non-negotiables” regardless of the Defined Autonomy System. The following are some examples of key requirements that apply across the District:

- **Schools will use the District principal and teacher evaluation systems.**
- **Schools will follow the District’s protocols for the provision of special education services.**
- **Spot observations must be conducted per the evaluation system.**
- **Schools will ensure good, first instructional practices as defined by the District.**
- **Schools will implement the District’s four core instructional practices: lesson objectives; demonstrations of learning; engagement strategies; and purposeful, aligned instruction.**
- **Schools will submit school action plans and budgets per the District timeline and use the District’s templates.**
- **No contractors or vendors are allowed on “the instructional field.”**





2024-25 Updates


Required New: Math and English

- **Students will receive a daily minimum amount of instructional time (90 minutes) in Algebra, English 1, and English 2.**
- **Select and utilize a high quality curriculum for English, Math, and Science.**
- **Principals will submit their budgets with preliminary purchased services and program selections by April 15.**
- **Division leadership will review and approve purchased services and programs line-items based on campus impact data.**


