Jaime Davila Elementary Parental Involvement Policy

Part I. General Expectations

Jaime Davila Elementary agrees to implement the following statutory requirements:

5. Jaime Davila Elementary will, at parents' request, provide opportunities for regular meetings for parents to formulate suggestions and participate as appropriate in decisions about their children's education. The school will respond to any such suggestions as soon as practicable possible by:
 - *Setting up requested meetings in a timely manner*
6. Jaime Davila Elementary will provide each parent with an individual student report about the performance of their children on the State Assessment in math, reading, and science by:
 - the end of 2023-2024
7. Jaime Davila Elementary will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710 December 2, 2002) by:
 - *Communicate to parents via letter immediately*
8. Jaime Davila Elementary will assist parents of children served by the school as appropriate in understanding topics by undertaking the actions described in this paragraph:
 - The state's academic content standards
 - The state's student academic achievement standards
 - The state and local academic assessments, including alternate assessments, the requirements of Part A
 - How to monitor their child's progress and how to work with educators
 - a) *Hold Conferences*
 - b) *Explain the curriculum in their language*
 - c) *Provide Calendar with testing dates*
9. Jaime Davila Elementary will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology as appropriate to foster parent involvement by:
 - *Host Family Literacy Nights*
 - *STAAR Night*
 - *FACE Workshops*

10. Jaime Davila Elementary will, with the assistance of its parents, educate its teachers, pupil services, personnel, principals, and other staff on how to reach out to communicate with and work with parents as equal partners in the value and utility of contributions of parents and how to implement and coordinate parent programs and build ties between parents and schools by:
