General Assessment and Reporting Guidelines

HISD policy for grade reporting is for every teacher to assign at least 2 grades per week within a grading cycle. Cycle grades will be reported on a range of 0–100. Grades recorded in teacher grade books over a grading period may range from 0–100 based on the actual score earned by the student. The actual grade assigned by the teacher will appear on the report card. Students must be given opportunities to make up or redo a class assignment or examination for which the student received a failing grade.

MYP Assessment and Reporting for All Subject Groups

All assessments used in the MYP unit planner will be criterion-related and grade utilizing a "best-fit" approach on subject-specific rubrics.

<u>**Criterion-related</u>** - An assessment process based on determining levels of achievement against previously agreed criteria. The standard is therefore fixed rather than depending on the achievement of the or an entire cohort of students.</u>

Best-fit - A process where teachers work together to establish common standards against which they evaluate each student's achievement holistically.

In addition:

- Rubrics used will come from the appropriate IB MYP subject guides and modified by subject area teachers so that they are **task specific and age appropriate.**
- The kind of generic application of broadly constructed criteria that must be utilized in determining achievement levels awarded on rubrics is "criterion related" assessment.
- This differs from criterion-referenced assessment in that it does not require a mastery of each descriptor to award a level of achievement and better describes what is called a "best-fit" approach.
- Rubrics MUST be provided to students before the assessment is given.





- Students MUST have the opportunity to self-assess using the rubrics.
- Percentage grades MUST be determined using the appropriate IB MYP conversion chart, authored by the school.
- Percentage grades AND rubric grades must both be reported back to students on subject specific MYP unit assignments.

Summative Assessments and Criterion Grading

<u>Summative Assessment</u> - Assessment aimed at determining the competency or level of achievement of a student generally at the end of a course of study or a unit of work. Examples include research-based essays, investigative labs, creation of products, objective-based tests, performances, etc.

MYP assessment requires teachers to assess the prescribed subject-group objectives using the assessment criteria for each subject group in each year of the programme. Across a variety of assessment tasks (authentic performance of understanding), teachers use descriptors to identify students' achievement levels against established assessment criteria below.
