**Course Description:** The course provides the knowledge and skills necessary to prepare students for a career in law enforcement. This course includes the ethical and legal responsibilities, operation of police and emergency communications equipment, and courtroom testimony.

  - b. Criminal justice system components and function
  - c. Law enforcement careers
2. Courtroom Procedure
  - a. Understand the roles of trial participants
  - b. Prepare testimony from reports
  - c. Present testimony during a mock trial
3. Crisis Management and Conflict Resolution
  - a. Demonstrate crisis negotiations
  - b. Participate in simulated crisis negotiation scenario
  - c. Examine anger management techniques
  - d. Discuss strategies for dealing with difficult people
4. Civil and Criminal Law Procedure
  - a. Research civil and criminal law procedures
  - b. Examine limits on use of force in both procedures
  - c. Differentiate between various forms used in civil and criminal law procedures
