Board of Education Meeting on December 13, 2012

SUBJECT: BOARD MONITORING SYSTEM—GOAL 1, SECTION C: MAINTAIN PROMOTION STANDARDS/HIGH SCHOOL CREDIT STATUS

At the February 11, 2010 meeting, the Board of Education implemented a revised Board Monitoring System in order to efficiently maintain and measure achievement of Houston Independent School District (HISD) goals and adherence to its core values. The monitoring system was designed to give district administrators clear direction on how to meet the board's expectations in these crucial areas.

Board Policy AE(LOCAL) states “[T]he administration shall report to the Board of Education on each goal and core value using the specific method and timing set out below,”

In reference to the district's **Goal 1: Increase Student Achievement**, the attached report provides information regarding **Section C: Maintain Promotion Standards/High School Credit Status**. The policy states that “*the Administration shall provide the Board of Education with a series of bar charts. The first shall show (for the school year completed one year ago) the total number and percentage of students meeting promotion standards during the regular school year, students not meeting promotion standards during the school year, but meeting the standards after summer school, and those not meeting promotion standards either after the school year or summer school. The second bar chart shall show the number and percentage of those same students promoted and not promoted the following year. The Administration shall also provide a bar chart showing, for the just completed summer school session, the total number of students referred to summer school, number attending, number completing, number promoted and number retained. For students whose final status was determined by committee decision, the number and percentage of students by reason leading to committee decision will be provided (e.g., GPC, ARD, LPAC, parent request, etc.).*

The Administration shall also provide a table showing promotion statistics, by school, including the total number of students whose promotion was considered by a grade placement committee, reflecting the total number of students promoted and retained. An additional table will show the committee reasons by campus for those campuses with more than 10 percent of their students promoted by committee decision.

Additionally, Administration will provide a table by high school reflecting the number and percent of students completing enough credits to move to the next grade level and the percent of students by grade level on track to graduate in four years of becoming a ninth grader. The high school data will also show the number and

percent of 9th grade students who have failed 3 or more courses the previous school year.

The Administration will also provide as an attachment to the Monitoring Report, the annual Promotion Standards report that shows promotion/retention data by grade for Title I and non-Title I students. Target: The percent of students who meet promotion standards during the regular school year will increase to 90 percent and to 98.5 percent after summer school by the end of the fall semester 2012. Other measures are report only for the first year.”

The attached report provides the promotion standards information requested for the 2010–2011 school year and the high school results for the 2010–2011 and 2011–2012 school years. This report directly supports HISD’s Strategic Direction for Core Initiative 4: Data-Driven Accountability.



Board Monitoring System: Goal 1-Section C

EXECUTIVE SUMMARY

Purpose

The Houston Independent School District (HISD) exists to strengthen the social and economic foundation of Houston by assuring its youth the highest-quality elementary and secondary education available anywhere. In fulfilling this goal, the HISD Board of Education has designed a program to systematically monitor the district's goals and core values. The Board Monitoring System will report on each goal and core value on a routine basis. The goal currently under review is to MAINTAIN PROMOTION STANDARDS among students in grades 1–8 (Goal 1, Section C). Additionally, high school students' progress in earning credits to advance to the next grade level and stay on track to graduate in four years are also reported.

Findings

Promotion Standards/High School Credit Status

- Eighty-eight percent of HISD students in grades 1–8 met promotion standards at the end of the 2011–2012 school year, which is an increase from 83 percent in 2010–2011. Twelve percent of students in grades 1–8 did not meet promotion standards in 2012 compared to 17 percent in 2010–2011 at the end of the regular school year. The total percentage of summer school attendees in grades 1–8 meeting promotion standards after summer school increased from 78 percent in 2011 to 83 percent in 2012. The total percentage of students in grades 1–8 meeting promotion standards increased from 95 percent in 2011 to 96 percent in 2012 after summer school (**Figure 1**).
- The percentage of students promoted because they met promotion standards increased from 81 percent in 2010–2011 to 87 percent in 2011–2012. Those students promoted on the basis of committee decisions decreased from 13 to 9 percent. The percentage of students retained because they did not meet promotion standards decreased from 5 to 4 percent, and the percentage retained on the basis of committee decisions remained less than 1 percent (**Figure 2**).
- The actual fall 2012 grade status for students in grades 1–8 (that is, comparing the grade levels of students from the 2010–2011 school year with their grade level in fall 2012) showed that 98 percent were promoted and 2 percent were retained. These rates are consistent with the rates from 2010–2011. Students who did not return were removed from the analysis (**Figure 3**).
- A total of 14,120 students were referred to summer school at the end of the spring semester in 2012. At the end of summer 2012, 65 percent of the students (9,242) referred to summer school met promotion standards and were promoted to the next grade. This is a decrease from 2010–2011 where 69 percent of the students (13,819) referred to summer school met promotion standards. In 2012, 13 percent of the students (1,891) referred to summer school were retained, and 21 percent (2,987) did not attend summer school. In 2011, 19 percent of the students (3,800) referred to summer school were retained, and 12 percent (2,357) did not attend summer school (**Figure 4**).
- At the end of the 2011–2012 school year, 10,335 students were promoted by committee decisions compared to 16,146 students at the end of 2010–2011. The number of students being retained based upon committee decisions increased from 68 students in 2011 to 83 students in 2012 (**Table 1**).
- During the 2011–2012 school year, twelve campuses promoted a total of 100 percent of their students:

- Bush (547 students based on promotion standards and 20 students based on committee decisions),
 - Lovett (540 students based on promotion standards and 9 students based on committee decisions),
 - Roberts (all 591 students based on promotion standards),
 - Shearn (326 students based on promotion standards and 7 students based on committee decisions),
 - Energized for Excellence MS (319 students based on promotion standards and 17 students based on committee decisions),
 - Energized for STEM Southeast MS (70 students based on promotion standards and 14 students based on committee decisions),
 - Energized for STEM West MS (267 students based on promotion standards and 19 students based on committee decisions),
 - Kaleidoscope School (all 105 students based on promotion standards),
 - Project Chrysalis (192 students based on promotion standards and 5 students based on committee decisions),
 - Rice (1,095 students based on promotion standards and 11 students based on committee decisions),
 - Rogers (562 students based on promotion standards and 140 students based on committee decisions), and
 - Young Men’s College Prep. (99 students based on promotion standards and 1 student based on committee decisions) (**Appendix A**).
- During the 2011–2012 school year, two campuses retained a total of 100 percent of their students: SOAR Center (all 31 students based on promotion standards) and Texas Connections Academy (all 1,457 students based on promotion standards). Of the non-alternative non-special education schools, the three campuses with the highest retention rates were Foster with 14.4 percent (44 students based on promotion standards), Kashmere Gardens with 12.5 percent (36 students based on promotion standards), and Isaacs with 12.3 percent (42 students based on promotion standards).
 - For the 2011–2012 school year, there were 48 schools which promoted more than 10 percent of their students by committee decision. This is an improvement from 2010–2011 where 94 schools met this criterion. High School Ahead had the highest rate with 95.9 percent of its students promoted by committee decision (3 students by Attendance Committee and 277 students by Grade Placement Committee). Of the non-alternative non-special education schools, the three campuses with the highest rate of promotion by committee decision were Briar Meadow with 67.9 percent (14 students by ARD and 306 students by Grade Placement Committee), Black with 49.2 percent (29 students by ARD, 83 students by Attendance Committee, and 156 students by Grade Placement Committee), and Fondren Middle School with 49.2 percent (9 students by ARD, 241 by Attendance Committee, and 84 by Grade Placement Committee). Of all the committees, Grade Placement promoted the highest number of students, followed respectively by Attendance, ARD, and Principal Plan (**Appendix B**).
 - Districtwide, the percentage of high school students with enough credits to advance increased with each grade level at the end of the 2011–2012 school year. Percentages ranged from 72.1 percent of ninth grade students with the minimum number of credits to advance to 92.9 percent of twelfth grade students with enough credits to earn the core minimum diploma. However, only 83.5 percent of the twelfth grade students have passed the TAKS requirement to graduate. Overall, the numbers and percentages of students with the minimum number of credits to advance to the next grade or graduate decreased from 2010–2011 across all grade levels (**Appendix C**).
 - Eighty-six percent of ninth grade students who are currently enrolled are eligible to graduate in four years. Six schools had 100 percent of their students in grades 9–12 on track to graduate in four years: Carnegie Vanguard High School, DeBaKey High School, Empowerment College Prep High School, Energized for STEM Southeast High School, Energized for STEM West High School, and High School for the Performing and Visual Arts. Percentages were calculated based on when students were enrolled for the first time in ninth grade. There were 2,674 students (5.6 percent) whose first year in ninth grade was not available (**Appendix D**).

- The district had 3,983 ninth grade students enrolled in high school who failed three or more courses the previous school year. Overall, the percentage of ninth graders who failed three or more courses the previous year increased from 20.1 percent in 2010–2011 to 22.7 percent in 2011–2012. The failure rate of three or more courses for district high schools ranged from 3.7 percent (Jordan High School) to 46.9 percent (Hope Academy). Chavez High School had the largest number of ninth grade students (311 or 26.3 percent) who failed three or more courses the previous year (**Appendix E**).
- Title I students represented 92.5 percent or 111,055 of all students in the district in grades 1–8. Of these students, 8.1 percent were promoted based on committee decisions compared to 7.2 percent of Non-Title I students. Based on promotion standards, 88.4 percent of Title I students were promoted, 74.6 percent of Non-Title I students were promoted, 2.8 percent of Title I students were retained, and 18.0 percent of Non-Title I students were retained. The percentage of students retained by committee decision was 0.1 percent for Title I students and 0.2 percent for Non-Title I students (**Appendix F**).

Administrative Response

High schools in the Houston Independent School District are ensuring that students proceed to the next grade level and stay on track for graduation through the following actions:

- **Providing multiple opportunities for credit accrual, both for original credit and credit recovery in settings such as:** Winter Session classes, Spring Break classes, Summer School and Extended Summer School, off-semester courses (e.g. offering Algebra 1A in Spring for students unsuccessful in Fall, or offering Geometry B in Fall for students unsuccessful in the previous Spring), and Grad Lab courses.
- **Anticipating and responding to students' unique academic needs and gaps by employing:** double-blocked classes in reading and math, tutorial support in small group settings, EVAAS projection measures to identify students who may face difficulty on STAAR EOC exams, a Reading Intervention class for all Grade 9 students scoring below the 50th percentile on SAT-10, the Student Risk Indicator report which enables principals and other educators to monitor students most at risk in the school based on attendance, standardized test scores, formative assessments, discipline referrals and projection measure, and cohort-tracking tools that include grades, credits and test scores for students by expected year of graduation (based on first year in Grade 9).
- **Guiding schools in the creation of systems at all campuses that focus on dropout prevention, intervention and recovery by:** hosting monthly HS Office DRIP meetings highlighting best practices (hosted by schools with excellent practices), developing a Dropout 101 course for principals and leadership teams, hosting a discipline summit for high school principals during which new discipline guidelines were created focused on positive behavioral intervention versus immediate referral to DAEP, and encouraging the use of freshmen orientation camps and/or first-week suspended curricula for freshmen guidance and orientation.
- **Specifically monitoring failure rates including:** by teacher, by course, by school (every six weeks and every nine weeks depending on the report card used by the school) and overall across the district, and by student for students failing three or more classes at the close of a semester.

Middle schools in Houston Independent School District are ensuring promotion standards among students in grades 6-8 through the following actions:

- **Guiding schools in the establishment and utilization of their grade placement, attendance, and ARD/IEP committees by:** hosting best practices sessions at monthly MS Office Principal's meetings, coaching and mentoring of principals and their leadership teams in making promotion decisions effecting students who have not satisfied all promotion standards, and conducting regular,


targeted monitoring of the instructional practices and committee actions of those schools with the highest rate of promotions by committee decisions.

- **Recognizing that early intervention in middle school is critical in meeting promotion standards and reducing the dropout rate by:** continuing the success of the High School Ahead Academy in providing structured prevention and intervention efforts for overage middle school students; but recognizing that High School Ahead Academy addresses only a small percentage of overage students, exploring options for expanding overage programs to other campuses; working closely with campus DRIP teams to identify and share best practices and strategies for addressing dropout prevention and intervention; and incorporation of the District's new discipline guidelines with a focus on positive behavioral intervention versus immediate referral to DAEP.
- **Improving dialog with parents or guardians of students who have not satisfied promotion standards, but cannot attend summer school to:** assess the student's potential for success at the next grade level, determine the extenuating circumstances that prevent summer school attendance, and development of possible alternatives to regular summer school for meeting promotion requirements.

Elementary schools in the Houston Independent School District are ensuring that students proceed to the next grade level and stay on track for graduation through the following actions:


- **Providing multiple opportunities for student success within and outside the regular class day:** Campuses will continue to monitor student success through the use of Rtl and IAT. Students in need of additional support to reach mastery will be provided support through tiered instruction within the classroom, pullout intervention programs, and extended instructional days through after school and Saturday intervention programs.
- **Early interventions of students who may be at risk of failure:** Campuses are reviewing mid-cycle progress reports and report cards to ensure that failing students receive intensive intervention early. Use of I-station as a reading screener and progress monitoring tool will be monitored to ensure targeted reading instruction is occurring and achievement gaps are closing. The Ed-plan formative assessment tool will also be utilized to monitor mastery of grade level student expectations.
- **Supporting schools in identifying and monitoring overage students that are failing after each grading cycle:** A focus continues on providing schools timely data and information related to overage and at-risk students. This includes using the student risk factor report that utilizes several indicators to determine the students most likely to be retained and become eventual dropouts. Progress and interventions of these students are closely monitored through report cards, benchmark assessments, attendance, etc.
- **Offering Summer school program to address student failures:** Schools have created intensive intervention programs that allow specific focus for students who did not meet the promotion standards for the district. After summer school over 83% of students that attended the programs were promoted.
- **Monitoring the promotion retention standards and preparing for changes:** The promotion standards for elementary students have changed over the last two years and will most likely change again this year. This includes the removal of the Stanford criteria for promotion two years ago and due to new state testing no state standard this year. Schools have shown an increase in the number of students being promoted over the last two years and we want to ensure this process continues. Last year the only two promotion criteria that were used were report card grades and attendance. We are anticipating some additional criteria for the new STAAR test that will be included in the promotion standards. This may increase the likelihood of more students missing one of the promotion standards.


Note: Students with data discrepancies were included based on Spring promotion status. Spring promotion target is 90.0%, and Total promotion target is 98.5%.


