Developing Guiding Principals

1. What does learning look like in the 21st Century?
 - a. Curriculum should incorporate project based learning.
 - b. The space should allow for both individual and collaborative learning.
2. What role will technology play in 21st Century Learning?
 - a. Technology should be well integrated into the building.
 - b. Technology within the building should be interconnected.
 - c. Wi-fi should be accessible to the community and students after hours.
3. What do you envision when you think of all learning spaces as workrooms for learners?
 - a. The spaces should be flexible.
 - b. Classrooms should not have traditional desks
 - i. Allow for individual and/or group learning arrangements.
 - c. Spaces that make collaboration possible.
4. What are the opportunities, challenges, assets, and hopes for your school and your community?
 - a. Opportunities: workforce services for the community; community accessible wi-fi hot spot.
 - b. Hopes: accessible to the community; dedicated to community enrichment; services available to students.
 - c. Sterling is unique with the rural land that surrounds the school.
 - i. "Come on a Sunday and you will see more horses than cars."
5. How can a building that is made to last for decades respond to ever-changing instructional models and evolving technologies?
 - a. The building should be modular and flexible.

2. Does HISD have anything planned for the site where Frost Elementary School was previously located?
 - a. The Board of Trustees determines the use or disposition of vacant sites.
3. Safety and security are of utmost importance when designing the new school.
 - a. The new school should not be as close to the street as the current building.
 - b. Access to the new campus and the building should be easily regulated.
 - i. There should be minimal entries into the new building.
4. Sterling High School is currently in the top 9% of all High Schools in the United States.
5. 95% of Sterling's students qualify for medical assistance.
6. The new building should be a "24 hour" community hub.
 - a. "To some kids, this building is the only place they can be a kid".
 - b. "Kids have to depend on each other".
