PURPOSE: The purpose of this meeting was to update the PAT on the status of construction.

DISCUSSION:

- 1. Steven Gee, HISD Project Manager, welcomed the Project Advisory Team (PAT) to the June 2015 meeting and opened the meeting with an agenda review.
 - Mr. Gee notified the PAT that the portable buildings would not have to be moved. Principal Greenberg informed the PAT of the vestibule change made, which negates the need to move the portable building.
- 2. Keith Robinson, Division One Superintendent gave the following construction progress report.
 - The sub-contractor has drilled and poured 152 of the 208 piers to date.
 - The plumbing and electrical subs will begin installing underground utilities July 1, 2015.
 - Once the underground utilities are complete in Area C the trades will move to Area B and then the concrete sub will start forming and pouring the slab grade beams in Area C. This sequence would continue until the foundation is complete.
 - Division One is expecting steel deliveries the first week of August.
