### **DISCUSSION:**

The Program Manager, Douglas Lacy, informed the PAT the parking agreement is signed by all
parties. The City of Houston has requested the permit drawings, acknowledges the parking
agreement.

2. The Program Manager, informed the PAT, the subcontractor bids for the required scope of work outlined in the 85% construction documents were received on 11 June 2015 by the CMAR, the KBR Building Group.

- 3. The PAT were reminded, Centerpoint Energy shall start the relocation of the existing gas line that feeds the building on 13 July 2015. The site plan which identifies the scope of work has been submitted to Centerpoint. A phone call shall be placed to Centerpoint by the Program Manager on the 01 July to follow up on the start date.
- 4. The CMAR (KBR) shall submit to HISD Facilities the Draft Final GMP (Guaranteed Maximum Price) for the erection of the new Sharpstown High School through email on 30 June 2015
- 5. The Program Manager identified the tentative start of construction as August 2015, if the CMAR pricing of the GMP (Guaranteed Maximum Price) is within the construction budget for the project.
- 6. Adam Weiss, Project Architect, for the joint venture of Munoz/AUTOARCH, Architects, informed the PAT of the status of the Early Release Package permit drawings in review with the City of Houston. Expected permits for ERP #1 (Underground Utilities & Earthwork) expected within the next two weeks. ERP #2 & #3 were resubmitted for the second review this past week. No timeline has been identified of the approximate approval date.
- 7. Mr. Gasparello, read to the PAT, a letter received from Community Member, Sue Lloyd in reference to her participation in the design of the Spark Park for the new school. Ms. Lloyd participated in PAT Meetings in the months of February and March during the design discussions of the Spark Park. The current request addresses the need for a meeting to continue or open up further discussions of the park design. The PAT agreed to meet with her on 26 June 2015 at 3:00 PM
