### 1. Update on Plans

- a. FHHP Has submitted the plans to the City of Houston for permit. First comment expected by the end of October. We are on track for January 1, 2016 construction permit.
- b. City Sign-off on JRC expected with the next week. Street and utility demolition contractor will start soon after.

- f. The alumni committee ask if the commemorative trees in the spark park would be relocated.

- 3. Geological fault discussion.
  - a. The impact of the fault was discussed again for those who missed the last few meetings.
  - b. The redesign of the building has moved all building a safe distance from the fault line.
