**PURPOSE:** The purpose of this meeting was to discuss the updated entryway and to update the PAT on the construction process.

## DISCUSSION:

1. Property Acquisition:
  - a. The School district is close to owning each of the existing homes
    - i. The district expects to own all property within the month
    - ii. It does not appear as though the current residents are moving out very quickly
  - b. Asbestos abatement contractors have begun working on the owned property and have completed almost two thirds of the homes
  - c. The PAT asked about the extent of the fence that will be surrounding the property out of concern for the neighbors across the street on 43<sup>rd</sup> street. The entire area will be fenced once construction starts.
  - d. The PAT noted that there was additional development going on in the neighborhood and suggested that the team could follow the other project at H-GAC.org (Houston Greater Area Council).
2. Schedule Update:
  - a. Progress
    - i. The PAT members asked if the project was progressing according to the anticipated schedule. Amanda Goodie informed the PAT that the project on schedule and expects the abatement of the homes to start next month.
    - ii. The PAT asked what they could expect as far as a groundbreaking ceremony. Amanda Goodie offered that HISD had submitted an informational document to the Principal and would follow up as to what she was expecting.
  - b. Potential Delays
    - i. The PAT asked if there were any potential delays with the existing residents moving out. The issue was discussed with the implications of a possible reluctance to vacate the homes.
3. Entryway Update
  - a. The Architect explained that there was no update to the entryway design due to the pricing / budget / permitting process. The architect presented the status of the permit drawings as a way of explaining the items that remain unresolved. The items left to be resolved primarily had to do with the structural for the main entryway. The architects are waiting on notes from the city's structural department, and the constructability review from the CMAR. This will be resolved before the final 100% drawings are submitted for the 2<sup>nd</sup> round review to the City of Houston Permitting Department.
4. Student Involvement in the construction process:
  - a. The Architect reported that they had met with the Construction Engineering instructor at the school and will begin working with that program over the next two months. They will provide instructional assistance for the coming design sections of the class: November 11, 2014 and December 11, 2014.
