2. Project Timeline
 - a. Sept: **PAT Meeting, Thursday Sept 17 @ 5:30 PM**
 - i. School of Communications Presentation – Features, Functions, & Aesthetics
 - b. October: **PAT Meeting, Thursday October 15, 2015 @ 5:30 PM**
 - i. Meeting with CMAR to discuss the construction schedule
3. School of Communications Presentation
 - a. PAT – Questions Can a list of equipment to be in School of Communication (SOC) can be provided.
 - b. HISD – Replied that a list can be provided next month
 - c. PAT – Questions square footage of the Audio Video Room
 - d. Moody Nolan – The Audio Video Room is 1,700 square feet
 - e. PAT – Questions why the SOC is upstairs instead of downstairs
 - f. Moody Nolan – According to the HISD design guide lines there were spaces in which a first floor location was mandatory. This did not leave enough space for the SOC on the first floor. Also it was expressed by HISD and some Yates administration to keep all SOC spaces together. The second floor provided space to satisfy all the aforementioned request/requirements.
 - g. PAT – Questions if the recording studio space is zoned separately to isolate control and security. Also concerned about the ability to keep the equipment from overheating when school is not in session.
 - h. HISD – Replied that they will look into the individual controls of the equipment.
 - i. Moody Nolan – The SOC has been designed to house all equipment with the interior environment, acoustics, and general function in mind. The design team will confirm and coordinate all equipment concerns with HISD and the necessary consultants.
 - j. PAT – Questions the height of the lights in TV Studio.
 - k. Moody Nolan – The bottom of the lights and rigging is approximately 13 feet above the finished floor.
 - l. PAT – Questions door size and entry/exit of storage area.
 - m. Moody Nolan – There are 8 foot double door openings and there is perimeter space provided for circulation throughout
 - n. PAT – Questions the location of the on air productions area
 - o. Moody Nolan – Explained that an open floor arrangement for on air production was given by an SOC instructor
 - p. PAT – Questions if the equipment in the photos is the equipment that will be given to Yates
 - q. HISD – All equipment shown are included in Yates project budget
 - r. PAT – Questions is budget due to inflation can give Yates the school they were promised
 - s. HISD – Explained how HISD has had to move funds such as reserved funds and inflation cost into the construction budget in order to offset the inflation spike and labor increase.
