### **Campus Parent and Family Engagement Policy 2022-2023**

North Houston Early College High School (NHECHS) is located across from the Northline campus of Houston Community College (HCC). The school gives low-income youth, prospective first-generation college students, English Learners (EL's), students of color, and others underrepresented in higher education the opportunity to earn a high school diploma and an associate degree or up to two years of credit toward a bachelor's degree, tuition free.

- NHECHS is committed to the education of the children in the community. The faculty, staff, and parents will share the responsibility for improved student academic achievement. The school will work to ensure that the required parental involvement meets the requirements of section 1116(b)(1) & (e)(5) of The Elementary and Secondary Education Parental Involvement Policy (ESEA Parental Involvement Policy) and Every Student Succeeds Act (ESSA).

- Timely information about our Title I-funded programs: PSAT and SAT preparation, Credit Recovery, Summer School, course tutorials, and interventions.
- A description and explanation of the curriculum in use at the school.
- Explanations of how student performance is measured.
- Explanations of how our school is performing in relation to expected proficiency levels on state mandated assessment measures such as the STAAR EOC, TELPAS, PSAT, SAT, and district mandated assessment measures.
- Principal and Parent Engagement meetings allow parents to discuss and make suggestions about the School Improvement Plan (SIP) that are implemented. If the SIP is not satisfactory to the parents/families of participating children, the school will submit parents'/families' comments on the plan to the External Funding Titles I, II & IV Dept. and revise the plan as advised by the HISD Title I, Part A Parent & Family Engagement Program Administrator and other district designees as advised.
- Assistance with technology and appropriate training to access resources.

#### **Shared Responsibilities for High Student Academic Achievement**

The School-Parent Compact has been reviewed and/or revised annually by NHECHS parents, faculty, and staff, including on September 8<sup>th</sup>. The School-Parent Compact outlines how parents/guardians, the entire staff of NHECHS, and students will share responsibility for improving student academic achievement and developing a partnership to help students achieve high academic standards. The School-Parent Compact describes the school's responsibility to provide high-quality curriculum and instruction in a supportive and effective learning environment. It also describes the ways in which parents/guardians will be responsible for supporting their child's learning and how they will participate in decisions relating to their child's education. Additionally, the compact details specific student actions that will contribute to their educational success at NHECHS. The School-Parent Compact is used to motivate students and parent/guardians to become more involved in the education process and inform them that they are equal partners in their child's learning as it highlights the importance of ongoing communication, parent-teacher conferences, progress reports/report cards, using PowerSchool, and more. The Compact ensures that faculty and staff assist parents with technology use and that all NHECHS students have Wi-Fi and laptops at home.

#### **Building Capacity for Involvement**

Participation and involvement of all parents is important at NHECHS. Information relating to school activities, student performance, parent programs, meetings, volunteerism, and other opportunities for participation are sent home in the home language. All standard informational announcements, including this policy and the School-Parent Compact are provided to parents/guardians in a language that they can understand. Title I notifications will be provided to each NHECHS student through their advocacy course. Additionally, parent/guardian educational sessions are held where presentations are designed to help them know how to access student progress information from Parent Student Connect, how parents/guardians can work with educators to help their students, and how to be involved in decision making about their child's education. Training is also provided to NHECHS teachers and other staff members. These professional development sessions teach school staff the importance of involving parents, role of parents as partners, programs available for parents, and methods for building ties between home and school.

Home visits are conducted by a designated staff member under certain circumstances. If it is impossible for a parent/guardian to come to the school due to illness or injury, and the parent requests a face-to-face meeting, a home visit may be arranged. If no valid telephone number for contact has been provided, a home visit could occur.

Additionally, we ensure that parents/guardians with disabilities may participate in all activities by providing handicap access to all areas of NHECHS.
