1. Call to Order:

- The meeting was called to order promptly at 3:00 PM by Dr. Fola Dimandja via Microsoft TEAMS.
- Dr. Dimandja opened the meeting with the presentation of the agenda and the goal.

2. Watch the SDMC Video:

• Dr. Dimandja served as the meeting narrator. She shared her screen to view the TES Framework slides and video as a group.

3. Explore and Discuss Resources about TES Framework:

Members explored and discussed various resources related to the TES Framework.

4. Preview and Discuss TES Framework Options using the Provided Deliberation Questions:

- After viewing the video, Dr. Dimandja presented each framework and its makeup. The committee previewed and discussed different TES Framework options using the provided deliberation questions.
- 5. Committee Deliberate and Decide on Top Recommended TES Framework:
- The committee continued to wonder, ponder, and discuss the frameworks using the deliberation questions given to make a decision.
- Member Washington stated her preference for Framework A. Her reasoning was that she felt the campus was already doing the necessary things to meet the standards of Framework A.
- Member Washington also expressed a preference for a framework design with a lower percentage for student achievement due to the uncontrollable variables that affect student achievement.
- Member Hollie asked if the percentage for the Quality of Instruction was solely based on the IIRT results.
- Dr. Dimandja provided the information from the slides to answer Member Hollie. The Quality of Instruction percentage was made up of SPOTs and formal 45-minute observations as well.
- Member Turknett expressed his rejection of Framework designs D and E because of the Student Survey component. His concern was about students having the ability to use their personal feelings and judgments to rate teachers poorly, which would be deemed unfair to the teachers. Other committee members were in agreement.
- Dr. Dimandja put forward the option to create a new framework design.
- Member Wilson provided the committee with the guidelines to create a new framework design.
- The committee rejected creating a new framework and decided to deliberate using the original five that were presented.
- After previewing the five TES Framework designs, each committee member was asked to cast a vote toward the recommendation for the campus.
- The vote resulted in a majority of 8 in favor of Framework A. 1 member voting for Framework B later changing mind to also select A.

9 VOTES FOR FRAMEWORK A

- Before closing the meeting, Member Wilson asked if the committee needed to address the early removal of students for any reason.
- The committee declined to open the discussion. No changes were made to early removal policy. Dr. Dimandja stated that the rules remain the same: parents must pick students up before 2:00 PM.
