## **Parental and Family Engagement Policy**

- *through prearranged monthly parent meetings*
- *through meetings with the student's teacher*

## RESPONSIBILITIES FOR HIGH STUDENT ACADEMIC ACHIEVEMENT

1. Tinsley Elementary School will build capacity for strong parental involvement to ensure effective involvement of parents and to support a partnership between the school, parents, and the community to improve student academic achievement through the following activities described below:
  - *monthly parent meetings/parent training*
  - *Curriculum/Family Nights*
  - *Support parental access to resources such as web sites, promotion standard resources, etc.*
