# J.W. Oates Elementary School Parent Family Engagement Policy 2024-2025

The staff, community and families are committed to working together to provide a successful educational experience for all students at J. W. Oates Elementary School. In consultation with teachers, principals, program administrators, and parents, a parent and family engagement policy has been developed and agreed upon. This policy shall be incorporated into J. W. Oates Elementary School's Title I requirements.

Oates is committed to providing a quality education for every child as stated within our mission, beliefs, and vision. When schools and parents form a strong partnership, the potential for student academic success improves greatly.

## I. Policy Involvement

To implement an effective program for parental engagement, Oates Elementary will provide the following:

- Oates shall convene two annual Title 1 meeting, at a convenient time, to which all parents of
  participating children shall be invited and encouraged to attend, to inform parents of their
  school's participation under Part A, and the right of the parents to be involved. Convene one
  of the meetings in the fall for all parents to meet staff at Open House to learn about the
  instructional programs offered at school.
- Offer a flexible number of meetings, such as meetings in the morning or evening.
- Involve parents in an organized, ongoing, and timely way, in the planning, review, and
  improvement of programs under Part A, if any. Exception: If a school has in place a process
  for involving parents in the joint planning and design of its general education programs, the
  school may use the process if there is adequate representation of parents of participating
  children, and it conforms to, and is effective in implementing, the parental involvement
  requirements of Part A.
- Provide parents of participating children information through monthly calendars, weekly newsletter and parent notifications:
  - a) timely information about Part A programs.
  - b) school performance profiles
  - c) their child's individual student assessment results.
  - d) a description and explanation of the curriculum in use at the school, the forms of assessment used to measure student progress, and the proficiency levels students are expected to meet.
  - e) opportunities for regular meetings to formulate suggestions, share experiences with other parents, and participate as appropriate in decisions relating to the education of their children, if parents express an interest in doing this.
  - f) timely responses to the suggestions made by parents that have been offered in meetings.
