Every campus under HISD will have the district centralized standard Parent/Student included in their campus specific handbook.

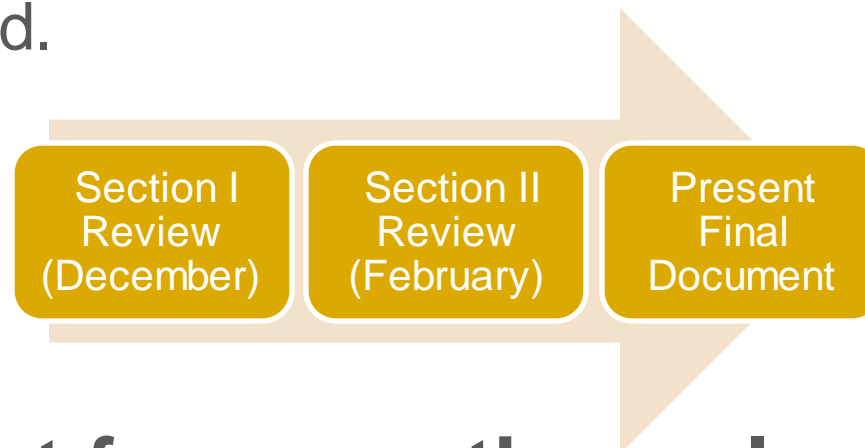
We've created this handbook to help parents and scholars understand the rules / expectations of district as whole and their specific campus.
