The HISD curriculum is based on the Texas Essential Knowledge and Skills (TEKS) and includes nonnegotiable objectives that must be taught at every grade level. However, individual schools are held accountable for innovative instructional programs and its instructional results. Every HISD student will be provided equal access to rigorous instruction and academic programs. PART I. GENERAL EXPECTATIONS

The <u>Jefferson Elementary</u> agrees to implement the following statutory requirements:

 - the requirements of Part A,
 - how to monitor their child's progress, and

- 9. <u>Jefferson Elementary</u> will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:
