  - a. Parents are invited to schedule conferences during teachers conference period. Teachers many also schedule parent conferences before and after school.
- 5. Provide parents with opportunities to volunteer and participate in their child's school, and to observe classroom activities.
  - a. Parents are invited to schedule a time to visit their child's classroom for a maximum of 20 minutes. (Parents must be VIPS approved)
  - b. We also invite parents to volunteer at the campus to help with programs, or clerical duties (cutting materials, etc...) (Volunteers must be VIPS approved)
