What are the return criteria for a student who goes home ill? Who goes home as COVID positive?	Will siblings of an ill child have requirements to return to school?
Does a parent need to share information with the school if they test COVID positive?	Will schools shut down if other schools in HISD are shut down for a COVID case?
Can we send a graphic of how a mask should fit on a face?	Will music look different with precautions about singing?
How specific will notice be when something is sent home about a positive COVID case?	How will we keep someone who may be COVID positive apart from the rest of the building?
Will there be a required type of COVID test that will be required to return to school?	If a student needs to quarantine will they automatically go virtual? Will they be able to come back to face to face?
How long will a student, who is sent home with a fever, need to stay home?	Will arrival and dismissal be staggered?
How will assessment differ for students who are online and face to face?	What are the HISD cleaning protocols?

Goal Area	SMART Goal (Specific, Measurable, Achievable, Relevant, Time-bound)
ELAR	The percent of Current EL students scoring at the meets grade level standard on the 2021 Reading STAAR will increase from 20% to 50%.
Math	The percent of Current EL students scoring at the meets grade level standard on the 2021 Math STAAR will increase from 33% to 50%.
Attendance	The attendance rate at Condit, for the 2020-2021 school year, will increase from 97% in 2018-2019 to 98% in 2020-2021.
Discipline	Maintain an out of school suspension rate of less than 5% and an in school suspension rate of less than 10%. In 2019-2020 Condit ES had 0 incidents of either.
Safety	Increase the number of parents who believe Condit is safe and secure on the EOY parent survey from 89% to 100%.
Community Involvement	Through the school and community partnerships Condit will offer at least 6 parent engagement activities throughout the year to engage all sub-populations.
Special Education	100% of our special education students are provided the accommodations and/or modifications based upon their IEP.
Special Population	The percentage of Economically Disadvantaged students passing STAAR Reading at the {Approaches} level will increase: in 3rd grade from 72% to 90%, in 4th grade from 77% to 90%, and in 5th grade from 69% to 90%.
