- V. Summer School, June 13 July 7

We have low summer school numbers, which is affording us the ability to do more TSI prep.

VI. Attendance criteria has been eliminated for final exam exemptions. If a senior meets the exemption status, the teacher will exempt that student. 9th-11th grade students must get the exemption signed by the teacher.

9th graders: exempt from 1 non-AP/non-dual credit course. Unlimited if they are in an AP course.

10th graders: exempt from 2 non-AP/non-dual credit course. Unlimited if they are in an AP course.

11th graders: exempt from 2 non-AP/non-dual credit course. Unlimited if they are in an AP course.

12th graders: no limitation

*We want to motivate students to earn the final exam exemptions. We may see an uptick in academic achievement.

*Open discussion about exemptions for the Fall semester next year. Ms. French-Lott said that she agrees with students having exemptions in the fall, but she uses the midterm to collect AP data and tracking purposes.
