	 Mrs. Khan-Wants credit recovery only for seniors and zero for math. Mr. Chang- States that too many credit recovery sessions are available for students. Students tend to know they will get away with doing credit recovery even though they fail during the semester. Schools like HSPVA, Bellaire, etc. Have a different caliber of students. But for the students to succeed, we need to have a different pathway for those students who are consistently taking credit recovery for their mathematics and other core classes. Mr. Chang- Those students who are not trying during both semesters should not have access to credit recovery. Credit recovery should be available those who have completed the majority of the coursework and have missed the threshold by a couple of points. Mr. Reyna- One solution could be the trailer courses or summer school. Mr. Chang- What if teachers nominate those students who do qualify for credit recovery? Mr. Reyna- Reconsider credit recovery plan, only offering courses to seniors. Freshmen through Juniors will need to attend summer school and or get offered trailer courses.
