SUBJECT: JUNE 2023 STAAR END-OF-COURSE PERFORMANCE

The Houston Independent School District (HISD) has received the results for the June 2023 administration of the State of Texas Assessments of Academic Readiness End-of-Course (STAAR EOC) exams. These exams are a graduation requirement and were given to eligible students who did not meet the satisfactory level of performance in previous administrations (retesters), as well as students who completed a summer school course and tested for the first time.

In general, students must pass the five STAAR EOC assessments (Algebra I, Biology, English I, English II, and U.S. History) to earn a high school diploma from a Texas public or charter school, as required in Texas Education Code (TEC) 39.025. House Bill 999, enacted by the 2021 legislature of the state of Texas, suspended these requirements for all 12th grade students if an individual graduation committee determines that a student is qualified for graduation.

Key Findings:

- Of the 10,725 STAAR EOC tests administered in June 2023, 55 percent (5,850 tests) were taken by ninth-grade students, 30 percent (3,183 tests) were taken by tenth-grade students, 14 percent (1,454 tests) were taken by eleventh-grade students, and 2 percent (207 tests) were taken by twelfth-grade students.
- Of the 5,850 STAAR EOC tests taken by ninth-grade students, 2,418 (41 percent) were taken in English I and 1,896 (32 percent) were taken in Algebra I.
- Students performing at or above the Meets Grade Level Standard ranged from 1 percent on Algebra I to 9 percent on U.S. History.
- Only four percent of testers were taking the EOC assessment with for the first time. U.S. History had the highest percent of first-time testers (21%)
- The percentage of students performing at or above the Meets Grade Level standard remains less than 10% across all five subjects during the summer administration.


