3.	<b>February SDMC Quarter 3 Presentation</b> <ul style="list-style-type: none"> <li>TES Agenda</li> <li>Goals for Today</li> <li>February Video</li> <li>TES Draft Framework (from January's Meeting)</li> </ul>	15 min	Barragato	<p>Mr. Barragato introduced the agenda for meeting our goals for the meeting and explained the TES up to this point. The video was played. Questions and comments included:</p> <ul style="list-style-type: none"> <li>We are a special program, and we need an appraisal system geared for our needs.</li> <li>How will TES improve on what we have?</li> <li>Wondering around why the district chose this particular framework over others.</li> </ul>
4.	<b>Planning and Professionalism Rubric</b> <ul style="list-style-type: none"> <li>Discussion and Feedback</li> </ul>	15 min	Barragato	<p>Mr. Barragato gave us a few minutes to look over the Planning and Professionalism rubric. After that time the SDMC discussed it. Questions and comments raised included:</p> <ul style="list-style-type: none"> <li>Planning for misconceptions: there needs to be more structured PLCs to internalize and show annotations.</li> <li>Admin will need to be on point and know the place in the lesson cycle. This could be accomplished by previewing the lesson plans ahead of time.</li> <li>The rubric for Growth Mindset is vague and allows for an opinion rather than measurable items.</li> </ul>

				<ul style="list-style-type: none"> <li>• Under Interventions: In order to get the highest rating it seems we would have to use the district resources rather than the ones we have been using.</li> <li>• Adheres to Deadlines: The district really needs to do a better job of informing administration of deadlines – everyone has to scramble with so many coming down at the last minute.</li> </ul>
5.	<b>Distinguished Teacher Overview</b> <ul style="list-style-type: none"> <li>• Discussion and Feedback</li> </ul>	15 min	Barragato	<p>Mr. Barragato gave us a few minutes to look over the Distinguished Teacher Review rubric. After that time the SDMC discussed it. Questions and comments raised included:</p> <ul style="list-style-type: none"> <li>• What does this look like for the DAEPs? We do not have extra-curricular activities, after-school tutorials, clubs, etc.</li> <li>• Student Impact: With our constant flow of students into and out of our program, how can we track their growth? The home school gets the money and credit for the year.</li> <li>• Is there going to be a rubric for specialty schools?</li> </ul>
